Many residents in the area have contacted main roads in regards to traffic banked up on Bussell hwy during peak hour and especially long weekends. I've asked them personally many times to consider placing "local traffic only" signs on Hasties and Gelorup rise where they meet Bussell hwy to stop traffic taking a google maps recommended detour down these roads along yalinda then to eucalypt drive and back out to the hwy where it's single lane and more difficult to reenter the hwy. The amount of traffic taking this detour when traffic is backed up on the hwy creates safety concerns regarding safe exit for residents in case of a fire. Also, would it be to much to ask to mark the intersections on the hwy at gelorup rise and hasties road with "keep clear" painted on the road so residents can exit the estate during busy times. Traffic banks up across the intersections and getting into Bunbury becomes almost impossible. negotiating the intersection to turn right (north) is downright dangerous. When we were first forced to use the Calinup Road junction we (and most of the other residents) recognized the dangerous situation due to the volume of traffic - reduction from 4 lanes to 2 - lack of visibility, and contacted the Hub and Main Roads - we were told that Traffic Management would be put in place as well as traffic lights. Since the so called traffic management has been operational the staff have been totally disinterested in local traffic (preferring to spend their days either chatting with each other or watching something on their phones) They have operated the traffic lights to enable the water trucks and dump trucks working on the BORR to cross Calinup Road and totally ignored the local traffic waiting up to 15 minutes for a gap in the traffic. We have repeatedly telephoned to complain about the lack of traffic management but nothing has improved.

- 5. Lack of visibility Calinup Road/Bussell Highway. Coming from Calinup Road with the intention of turning right (north) the signage that is placed on the road by the traffic management staff obscures visibility in most vehicles both 4 wheel drives and sedans meaning that we really do have to take our life in our hands to turn right.
- 6. Traffic jams at peak times most days at peak times there are traffic jams approximately 3 klms long and on Fridays and public holidays these are very much greater with traffic banked up from Hasties Road in Gelorup to Calinup Road this is such bad management surely there could be a better way of ensuring the traffic flow.
- 7. Due to the long delays caused by the traffic jams many vehicles are trying to find alternative routes through Gelorup townsite causing inconvenience to residents, unnecessary wear and tear on local roads and many extra traffic snarls in the area.
- 8. To be working on several large projects at the same time causes frustration for motorists as on a short stretch of road from Calinup Road to Washington Avenue on the Bussell Highway there are 3 major intersections being constructed with reduction from 4 lanes to 2 lowered

- speed limits altered speed limits at several sets of traffic lights. This adds up to huge frustration for motorists and we witness many acts of reckless driving on this stretch of road.
- 9. For a professional organisation with experience in constructing roads to ask for an extension of 10 months more than estimated is shocking illustrating how unprepared they are why should the local residents suffer because of this?
- 10. With Woods Road closed off this leaves only one way in and out of this subdivision which could be catastrophic in case of fire or other emergencies illustrated on 26th February 2024 when a bus decided to try and turn around in Manea Drive and succeeded in blocking the road and leaving us stranded.
- 11. There must be a solution to this problem to avoid keeping Woods Road closed for a further 8 months (and what is to stop Main Roads seeking another extension in October if one extension is already granted?).
- 12. We have voiced our concerns over the safety and inadequacy of this situation to many organisations only to have it fall on deaf ears will it take a serious accident to change the situation?

We are sure there are many more reasons why this extension should not be granted and re-iterate that we STRONGLY OBJECT to any extension to the closure of Woods Road etc.
