

5. **GENERAL BUSINESS**

- 5.1 Update on the Shire of Capel Economic Development Framework and Strategy
 - First stage is a 'desktop' exercise.
 - Limited progress achieved due to resourcing challenges.
 - Reached out to consultant to manage the process, finalising the scope currently. Consultants work to commence in early-2023.
 - Participated in the survey in Capel Wetlands progress on Kaatijinup.
 - Shire and Iluka have draft master plan.
 - Capel and Iluka will provide comment back by Christmas.
 - Feasibility study should be concluded 31 March, and is on track.
 - Working with DBCA, Iluka and Wadandi aboriginal elders.
 - Once feedback is provided to consultant, then will go back to steering committee.
- 5.2 Retail Trading hours – Community Consultation
 - Considered at the November 2022 Ordinary Council meeting, starting commencement of retail trading hours community consultation.
 - Bunbury deregulated 2015, Busselton are deregulated due to being a tourist zone.
 - There was a partial deregulation in the past, however there is still restrictions on businesses wanting to trade early or late hours, has impacted the Shire, particularly Dalyellup. Aim is to be fully deregulated (depending on community consultation).
 - Studies show there is a flow on of foot traffic to small business, aim to have something back to council in April.
 - Go through community consultation, there is a framework to follow. Then request is sent to the Minister, the Department will check that we have followed the correct process, before an approval.

• The consultation plan was an attachment to the Council report.

REPRESENTATIVE UPDATES

Regional Development Australia South West

- Completed project development workbook.
- Working on South West portal, to help assign people where to go.
- LRCI will be providing funding to the Shire, metro local governments are no longer eligible. •
- Funding through regional growth program
- There might be more work between RDA and Local Governments.
- Looking at forum for CEOs to discuss.
- Have problems with REMPLAN at the moment due to inconsistencies with the data.
- Been asked to work with policy pillars.
- Talking about job skills, renewables, closing the job gap etc.
- Planning Commissioner meeting clashes with WALGA zone, they are aware.
- Government will be working on housing on a state level.

Iluka Resources

- Kaatijinup progress been updated.
- Rehabilitation onsite investigation being completed for early new year. Will feed into mine closure plan.
- Done a few hectares of rehabilitation for 2022.
- Aguatic investigations have discovered endangered species within site inspections.
- SRI site project has commenced, is in commissioning phase. Iluka has employed 83 new employees. They have leased some properties for housing.
- Looking to install 100m wind mast for wind data for wind turbines. 7 to 8 turbines will offset their energy off the grid. 21 – 24 megawatts, modelling would cover Iluka. Still looking at the excess power either being stored or pushed back into the grid.
- The initial proposal is to be behind the metre so being pushed back into site, they are looking at batteries for extra storage.

Other EDAC representative updates

South West Development Commission

- Work has been focused on native forests, been working with businesses and communities. Will be busy with mill closures.
- Housing, land and worker accommodation, have asked Local Governments to fill out issues and priorities. Looking at business cases for funding for these projects.
- Project will be headed up for Minister.
- Been around 400mil of funding absorbed, so will work through with Local Governments.
- Don Punch was successful as a new Minister for Regional Development.
- (Andrew McRobert) Leaving the commission.
- Export and freight should be considered across the southwest.

Bunbury Geographe Economic Alliance

- Working with development WA on industrial land. Draft report being worked on what is available, what needs to be worked on and what needs to happen.
- Looking to run future jobs and skills network in March 2023.
- Has Shire considered protected cropping or housing? would be considered, would like to include Iluka.
